With the advent of neuromodulators such as Botox, Xeomin and Dysport along with dermal fillers such as Juvederm, Restylane, Voluma, Belotero and Radiesse, the need for surgery can be delayed and even deemed unnecessary for an extended period of time.

At Kiss Me, it is our goal to use the non-surgical tools that are available today in cutting edge techniques. Our staff has undergone rigorous training by continue to do so on an ongoing basis. Your satisfaction and safety is paramount. It is our philosophy that it is best to try non-surgical methods of lifting, tightening, resurfacing and plumping of the tissues before resorting to surgery. However, there are some cases which require surgical intervention.

We will do our best to treat you with non-surgical methods. If these methods are not satisfactory to you, or, if we feel we are unable to help you, we will advise you to seek surgical consultation. Kiss Me does not receive any compensation from outside surgeons and we suggest getting at least three (3) consultations with varying surgeons before making your choice.
